**THE PACESETTER:** Englander Krabe & Allen is the top local lobbying firm with \$5.6 million in revenue from lobbying activities in L.A. County last year. That's up \$600,000 from 2013. The downtown L.A. firm lobbies Los Angeles County and most of its cities as well as Orange, San Bernardino and Riverside counties. The firm was founded in 2005 and has 11 registered lobbyists.

**NEW:** Ek & Sunkin was founded last year focusing on development, energy and crisis management in Los Angeles County.

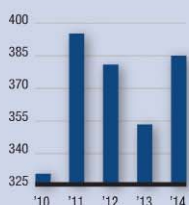
### Lobby Hobby
